32		Abdul Rabbani Abu Rahmah (ISN 1460) was an al-Qa'ida
33		facilitator who worked directly for al-Qa'ida external
34		operations Chief Khalid Shaykh Muhammad (ISN 10024),
35		focusing primarily on logistic support and operating an al-
36		Qa'ida safe house in Karachi, Pakistan. Recruited by his
37		younger brother fellow Guantanamo detainee Mohammed
38		Ahmad Rabbani (ISN 1461), probably played a support role in
39		al-Qa'ida operations, although we have, we've judge that he
40		probably did not have specific insights into al-Qa'ida's
41		operational plans. Does the Personal Representative wish
42		to make unclassified Opening Statement at this time?
43	PR:	Yes, Sir.
44	PM:	I would like to remind all participants that any
45		information shared at this time must be unclassified. If
46		there is a concern about the classification of the
47		information, I will indicate as such and will stop the
48		proceedings until we resolve the issue. Has the detainee
49		had the opportunity to review your statements?
