1	CA:	This Periodic Review Board is being conducted at 1005 hours
2		on 20 August 2019, with regard to the following detainee:
3		Abdullah Al Sharbi (ISN 682). As a reminder, the unclassified
4		portions of these proceedings are being recorded for the
5		purpose of generating a script, a transcript to be posted on
6		the PRS website. Representatives from the following agencies
7		are present and are members of the Board: Department of
8		Defense, Department of State, Department of Justice,
9		Department of Homeland Security, Office of the Director of
10		National Intelligence and Office of the Chairman of the Joint
11		Chiefs of Staff. The following personnel are also present:
12		Legal Advisor to the Board, Case Administrators, Personal
13		Representative, Two Translators, The detainee and the
14		Security Officer. The detainee, pardon me, the detainee's
15		Personal Representative, the detainee, and one translator are
16		located at the detention facility, US Naval Station
17		Guantanamo Bay, Cuba. He is attending via video
18		teleconference and the detainee waived translation of the
19		unclassified summary and the Personal Representative's
20		opening statement. These documents have been posted to the
21		Periodic Review Secretariat website. This session is being
22		observed by foreign, national and local media; Foreign
23		Government Officials and Representatives from Non-
24		Governmental Organizations.
25	PM:	Good morning, apologies for late start on the board this
26		morning. We had some technically difficulties in one of the
27		courtrooms and we had to move to our alternate courtroom and
28		that took a little effort. So sorry for the delay. But uh,
29		this board is convened to determine whether continued law of
30		war detention is warranted for Ghassan Abdullah Al Sharbi
31		(Ab-doollah Al Shar-Bee) (ISN 682) to protect against a
32		continuing significant threat to the security of the United

33		States. From here on forward, we will refer to the detainee
34		as Ghassan. This session of the hearing is unclassified.
35		Ghassan, this is your Periodic Review Board to determine
36		whether continued law of war detention is warranted in your
37		case. Continued law of war detention will be warranted if it
38		is necessary to protect against a continuing significant
39		threat to the national security of the United States. The
40		focus of this hearing is on the threat you may pose to the
41		United States and its interests if transferred or released
42		from US custody. It is not on the lawfulness of your
43		detention. The Personal Representative is your representative
44		to assist you during this process. Finally, the translators
45		ensure that everyone understands your statements and that you
46		understand what is being said during the hearing. Personal
47		Representative, has the detainee had an opportunity to review
48		the Unclassified Summary?
49	PR:	Yes, sir.
50	PM:	Thank you. I will now read the UNCLASSIFIED SUMMARY:
51		Ghassan Abdallah Ghazi al-Sharbi (ISN-682) attended a US
52		flight school in early 2001, where he associated with two 911
53		hijackers. He may have been involved in homeland attack
54		planning, possibly including the plot by Jose Padilla to
55		explode a radiological bomb. Sharbi was captured in 2002 at
56		the safe house of senior al-Qa'ida facilitator Abu Zubaydah
57		(ISN 10016) in Punjab Province, Pakistan. Does the Personal
58		Representative wish to make an unclassified opening statement
59		at this time?
60	PR:	Yes, sir.
61	PM:	I would like to remind all participants that any information
62		shared at this time must be unclassified. If there is a
63		concern about the classification of the information, I will
64		indicate as such and will stop the proceedings until we

65		resolve the issue. Has the detainee had the opportunity to
66		review your statements?
67	PR:	Yes, sir.
68	PM:	Okay, Personal Representative, you may now proceed.
69	PR:	Thank you, members of the Board, thank you for the
70		opportunity to present this opening statement for Ghassan
71		Abdullah Al Sharbi, ISN 682. Mr. Al Sharbi met with me on
72		five occasions this year but has refused to meet on my most
73		recent attempts in May, June, and July. Mr. Al Sharbi has
74		stopped attending meetings due to his displeasure in our
75		ability to provide him with a "Dream Team" of lawyers. Mr. Al
76		Sharbi continues to communicate through letters, but has
77		advised me that he will not attend our meetings again until I
78		get him a team of four lawyers from big firms and
79		specifically one firm that specializes in Public Relations
80		and one firm that currently represents the 911 victims. We
81		have made every effort to obtain legal counsel for Mr. Al
82		Sharbi; however, the lawyers who volunteer to take his case
83		are not the ones he wants. We will continue to reach out to
84		the Private Counsel that Mr. Al Sharbi requests in the hopes
85		that a PC that he is agreeable with will agree to represent
86		him. In addition, Mr. Al Sharbi is frustrated that the PRs
87		will not assist him in getting his story out to the press. I
88		have explained, in English and Arabic, the role of the
89		Periodic Review Secretariat and that the media are
90		authorized, and invited to attend portions of his hearing.
91		We will continue to schedule meetings and communicate through
92		letters in the hopes that Mr. Al Sharbi will reengage with
93		his Personal Representative and the Periodic Review Board. In
94		closing, I would like to thank the Board members for their
95		time.

98		Does anyone have a question at this particular time? Okay,
99		uh, with no questions, this concludes this portion of the
100		hearing. I ask that all remain seated until further
101		instructed by the Case Administrator.
102	CA:	We will now take a short recess to prepare for the remaining
103		sessions. Sir it will take them a couple minutes to get set
104		up, then we will be good to go.
105	PM:	How long do you think it will take?
106	CA:	Five minutes.
107	PM:	Well take five minutes and then we will reconvene. Commander
108		Board members remember that when the detainee makes
109		any statements, those states are presumed to be classified.
110		All questions need to remain at the unclassified level.
